Advocacy and Membership Committee

Accomplishments toward 2014-2015 Goals

- Conducted a member-wide Advocacy Round Table last June, and from that created the initial framework for Advocacy Plan
 1. **Definitions/Tracking of Vulnerable populations** – Medical Fragile kids – what happens to them when they go home with no services, especially in rural areas?
 2. **Creation of more Medical Home models** – possibly for Neurological Disabilities or Respiratory Dependent
 3. **Education and Training**- possibly to build family capacity for advocacy with the payors, advocacy for more internal case management, education of the Exchanges

Advocacy and Membership Committee Plans 2015-2016

- Increase Membership
 - Solicit additional membership for Advocacy and Membership Committee
 - Increase membership to 60 organization
- Increase Networking Opportunities
 - Increase Forum posts- *explore PUSH model*
 - 95 web site hits per month
- Increase advocacy with legislators and government agencies
 - Presence at 4 external events
 - Implement 3 items from Advocacy Plan

Accomplishments toward 2014-2015 Goals

- Supported IPRC 1-day pediatric track at the 2014 RCPA on-site conference
- Presented 6 webinars
- Participated in IPRC forum with education-related topic

Education Committee

Accomplishments toward 2014-2015 Goals

- Partnered with Best Practice IPRC committee to increase value of webinars- offered 6 networking calls
- Increased webinar attendance to an average of 41 with a high of 64
- Offered certificates of attendance
- Posted webinar presentations on IPRC website within 2 business days

Education Committee Plans 2015-2016

- Plan for on-site conference for 2016
- Present 6 webinars, including at least one from outside USA
- Explore options/Offer CEUs
- Increase webinar average attendance by 10% to 45
- Increase number of requested attendance certificates (current average 22) by 10 %

- Establish a Data sharing agreement for internal IPRC sharing - Achieved
- Data Collection
 - Vet the algorithms for each outcome against national benchmark (where relevant) - In progress
 - Pilot data platform with 5 hospitals – Not achieved

Outcomes and Research Committee Accomplishments toward 2014-2015 Goals

- Establish task forces to accomplish the following:
 - Research/investigate each Indicator, set formula's and establish Benchmarks – In progress
 - Collaborate with the Best Practices and Education Committees - Knowledge sharing – Not achieved

Outcomes and Research Committee Plans 2015-2016

- To have at least 10 hospitals sign the Data Sharing Agreement.
- Work with the third party vendor to get the dashboard online as soon as possible.
- Complete research assessment for alternative protocols to WeeFIM.
